### **(a) Medical Professes**

Avers that are remedial, inhibitory, or even health related, contravene the policies of RWPL and may also infringe the Laws and Regulations prescribed under law of India (Centre or State);

Therefore partners/renovians are rigidly counselled not to speak for company products to determine or assert to stop, obviate, remedy, heal, cure medicate or preserve any health conditions. In introduction of the information, no attempt should be made to provide analysis, care, ministrations or reformation of individuals, or solicit medical, mental health or human development principles, to provide preserving, obviating, operating or prescribing for any human ailments, pain, injury, deformity or physical state.

### **(b) Income Claims**

Renovian's/ Partners are impermissible to forge any wrong or deceitful representations about the Company, its products, company compensation plan, and income aptitude etc;

No income forecasts, income depiction, or showing of Renovian's Payout Statements shall be produced to eventual customers;

Do not use idiom like “retirement,” “magical product” “curing product,” phrases like “never work again,” “surplus income,” “passive income,” “royalty income” or “royalties,”

“always on travel,” “always travelling,” “liberty from work,” “free” etc as this may lead to misrepresentation of the Renatus Business or the Business Plan;

The use of terms that should be avoided are: “surplus income”, “passive income”, “royalty income” or “royalties” as these terms may suggest that one can continue earning even without putting in effort, which is not admissible;

Renovian's/Partners of RWPL are restrained from fabricating any independently-designed website relating to the Company Business or the Products. All Direct Sellers must receive advance authorization from the Company by submitting all promotional products such as Brochures, leaflets, standees, flyers etc. prior to their use. Violation of this article shall lead to termination of the Distributorship.

**(a) Miscellaneous**

Renovian's are not sanctioned to forge utilize of uncertified image/picture of any celebrity to display and sell products or to encourage and imply that the product has been inscribed by them;

Renovian's should rigidly consider that RWPL products shall exclusively sell to RWPL distributors, associates and products by making use of RWPL distribution network. Infringement shall lead to termination of the distributorship of the Renovian's;

Renovian's shall rigorously suggested not to sell, advertise or promote on any e-commerce retail or wholesale shopping sites, e-commerce auction sites, and e-commerce classified listings; not limited to Amazon.in, Flipkart, Snapdeal, Indiamart and ebay.in etc;



Distributors using their Facebook, Instagram, LinkedIn and other platforms to aggrandize the business must rigidly consider to adhere to the guidelines portrayed overhead. Any unsupported or false declaration made may lead to loss of reputation, credibility and reliability of Renatus Wellness Pvt. Ltd. and therefore shall attract to initiate disciplinary action and / or termination of Distributorship of the infringer.
